The Center provided 14,193 hours of partner abuse invervention services in FY20. Of the 662 individuals we served, 83% identified as men and 17% as women; 48% identified as African American, 27% Latinx, 17% Caucasian, 4% Bi-Racial, 2% Native American and 1% Asian/Pacific Islander. In addition, although we reached individuals across the age spectrum, over 70% of participants served were between the ages of 18-39, a trend that we expect to continue. Also of note is that more than one-third of our clients were unemployed and 68% reported annual earnings under \$20,000, which is why the sliding scale made possible through foundation and donor support was an important component in ensuring access to partner abuse intervention services and case management. And, perhaps most compelling is that 77% of those served had children who could be positively impacted as their parents learn the skills for building healthy relationships.

The Center provided 14,193 hours of partner abuse intervention services in FY20. Of the 662 individuals we served, 83% identified as men and 17% as women; 48% identified as African American, 27% Latinx, 17% Caucasian, 4% Bi-Racial, 2% Native American and 1% Asian/Pacific Islander. In addition, although we reached individuals across the age spectrum, over 70% of participants served were between the ages of 18-39, a trend that we expect to continue. Also of note is that more than one-third of our clients were unemployed and 68% reported annual earnings under \$20,000, which is why the sliding scale made possible through foundation and donor support was an important component in ensuring access to partner abuse intervention services and case management. And, perhaps most compelling is that 77% of those served had children who could be positively impacted as their parents learn the skills for building healthy relationships.
