The CADP served 575 unduplicated individuals in our minimum 24-week IDHS Protocol Approved Beliefs & Skills for Domestic Peace Partner Abuse Intervention Program during the peroid 7/1/21-6/30/22, an 8% increase over the previous year. The CADP provided services to individuals who primarily live on the south and westside of the City of Chicago and in DuPage County of which 55% had incomes of under 20,000. Another 19% had income under 30,000. Of the 575 individuals served, 181 successfully completed our PAI program and another 220 remained active into the next fiscal year. Most compelling is the 68% of those served had children-714 children- who were most likley impacted as their parents learned skills for healthier relationships.

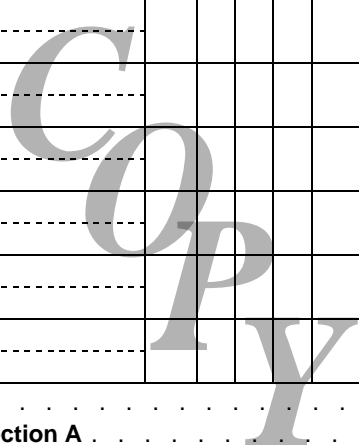
